Notice is hereby given that ScottishPower Renewables (WODS) Limited, ("the Company") with company registration number SC374288, having its registered office at the Soloist, 1 Lanyon Place, Belfast, Northern Ireland, BT1 3LP has applied to the Scottish Ministers for consent under section 36 of the Electricity Act 1989 to repower an existing wind farm generating station with an installed capacity in excess of 50MW to be known as Hare Hill Repowering and Extension on land approximately 1.5 kilometres (km) south east of the village of New Cumnock and 4.5 km west of Kirkconnel in East Ayrshire Central Grid Reference 65411, 08094. The installed capacity of the proposed generating station would be approximately 130 MW comprising of up to 23 wind turbines: 7 with a maximum tip height of 200 metres (m); 9 with a maximum tip height of 180 m; and 7 with a maximum tip height of 150 m. The proposed development is subject to Environmental Impact Assessment (EIA) and an EIA Report has been produced.

The Company has also requested a direction under section 57(2) of the Town and Country Planning (Scotland) Act 1997 that planning permission for the development be deemed to be granted.

A copy of the application, with a plan showing the land to which it relates, together with a copy of the EIA Report discussing the Company's proposals in more detail and presenting an analysis of the environmental implications, are available for public inspection in person, free of charge, during normal office hours at:

Written representations should be dated, clearly stating the name (in block capitals) and full postal address of those making representations.

All representations should be received not later than 06 MARCH 2026.

Any subsequent additional information which is submitted by the developer will be subject to further public notice in this manner, and representations to such information will be accepted as per this notice.

Where Scottish Ministers are required to, or decide to exercise their discretion to do so, they can cause a public inquiry to be held.

Following examination of the environmental information, Scottish Ministers will determine the application for consent in one of two ways:

- Consent the proposal, with or without conditions attached; or
- Reject the proposal
