1.1 PROPOSED LICENSABLE MARINE ACTIVITY

The proposed licensable activity is the construction of renewable energy structures within the Scottish marine area, in accordance with Regulation 4(2)(f) of the Marine Licensing (Pre-application Consultation) (Scotland) Regulations 2013.

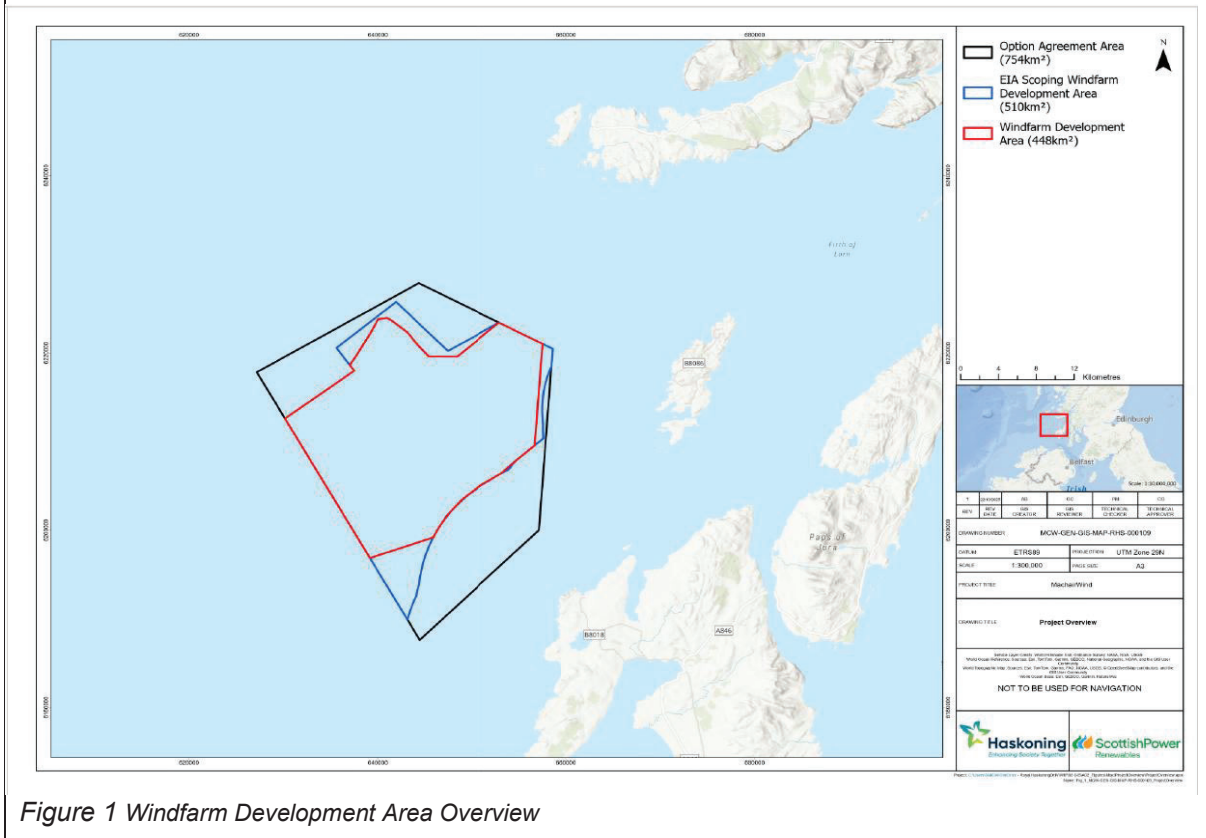


Figure 1 Windfarm Development Area Overview

This includes the installation of offshore wind turbine structures and associated offshore infrastructure, located within 12 nautical miles off the west coast of Scotland as seen in **Figure 1**.

The total area in which these structures will be located exceeds 10,000 square metres, therefore requiring a marine licence under the Marine (Scotland) Act 2010.

Separate marine licence applications will be submitted for:

- the Windfarm Development Area – construction of renewable energy structures;
- the Offshore Export Cable Corridor – installation of subsea cables and associated seabed works; and
- the Onshore Transmission Development Area, consented via relevant terrestrial planning processes.

Across the two consultation rounds, a total of 168 formal feedback responses were received. The most frequently cited feedback related to support for offshore wind in tackling climate change, alongside queries and concerns relating to the visibility of turbines from some of the islands. Questions were also raised relating to the perceived impact of the Project on the character of the islands, as well as environmental and engineering matters, including seabird and marine mammal surveys and infrastructure proposed within the Windfarm Development Area.

Several refinements to the Project were made between the first and second round of Statutory Consultation, as a direct result of stakeholder and community feedback.

The most significant change was the reduction of the WDA footprint by 12.16%, moving parts of the site further offshore to reduce potential effects on seascape, marine users and wildlife. The turbine design envelope was also refined: the maximum turbine height was reduced from 340 m to 335 m above LAT, and the maximum number of turbines decreased from 147 to 144.

Gravity Base Structures were removed from the foundation options, reducing seabed disturbance. In addition, the minimum air gap was increased from 22.45 m to 28.4 m above highest astronomical tide thereby reducing ornithological collision risk. These changes were communicated during the second statutory consultation under the "You said, we did" section of the Information Booklet, presented on printed and virtual maps, displayed on consultation banners, and discussed with attendees at PAC events.
