1. MARINE ACTIVITIES

1.1. Summary:

Mariners are advised that circa the 10th November 2025 guard vessel 'Mimer' will commence guard duty operations at the East Anglia Three Offshore Windfarm area set out in section $\underline{2}$ of this document.

During the construction of East Anglia Three OWF, vessels are requested to keep a 500m safety distance from all offshore construction vessels.

1.2. Activity Description:

The guard vessel 'Mimer' will monitor vessel traffic in and around the East Anglia Three Windfarm 24 hours a day, 7 days a week. The vessel will broadcast regular navigational warnings and will contact any non-project vessels they believe could cause potential hazards, risk of collision or cause an interruption to project vessels or assets.

Outer Thames Estuary Special Protection Area (SPA):

As required under Deemed Marine License Condition 13 (1) (c) (v) to minimise disturbance to red throated diver in the Outer Thames Estuary Special Protection Area (SPA) during construction of East Anglia THREE, these areas shall as far as practicable be avoided during transits from 01st November to 31st March.

1.3. Program Schedule:

Weather permitting, guard vessel duties will be carried out on a continuous basis (i.e. 24-hour working, seven days a week) until the end of the construction period.

The guard vessel 'Mimer' will monitor VHF Channel 16 and VHF DSC Channel 70 continuously throughout the operation as well as project specific radio channels.


