#### 12.5 CUMULATIVE IMPACT ASSESSMENT SCREENING RESULTS

#### 12.5.1 Introduction

- 1. The tables in this Appendix summarise the lists of plans and projects which have been screened into the marine mammals cumulative impact assessment (CIA) following:
  - a. Being within the agreed reference population boundary for the given receptor (see section 12.5 of Chapter 12).
  - b. Having the potential to cause the type impact which could have a cumulative impact with the proposed East Anglia THREE project (*Table 12.21* of Chapter 12).
  - c. Being from a tier (*Table 12.11* of Chapter 12) which is screened into the assessment.
- 2. The screening results are provided for each type of plan/project including other offshore windfarms, other renewable developments, aggregate extraction and dredging, licensed disposal sites, navigation and shipping, planned construction of subsea cables and pipelines and oil and gas installations (including surveying).
- 3. Any plans or projects that have the potential for a construction/commissioning cumulative impact that commenced construction/commissioning between the end of the baseline and submission of the ES will not be taken forward in the CIA for this type of cumulative impact. It is assumed that construction/commissioning will be completed before the start of construction of the proposed East Anglia THREE project.





#### 12.5.2 Other offshore windfarms

- 4. UK and European offshore windfarm projects considered in the CIA screening were categorised tier 1-5 (*Table 12.5.1* and *Table 12.5.2*).
- 5. UK based projects (*Table 12.5.1*) listed in tiers 1-4 were screened in for potential construction, operation and maintenance and decommissioning cumulative impacts, if those phases could overlap with the proposed construction, operation and maintenance, and decommissioning of the East Anglia THREE project and sufficient information and certainty in project programmes allowed for a meaningful assessment.
- 6. As a precautionary approach and to allow for any delays and changes in schedule, all UK consented (tier 3) projects were given a seven year window in which construction could occur and therefore potentially overlap with the proposed construction of the East Anglia THREE project (as discussed and agreed with Natural England, 6<sup>th</sup> July 2015) and for UK tier 4 projects (application submitted) the possible construction windows were based on the best available information (worst-case scenario).
- 7. As a more realistic approach, a second assessment (indicative scenario) included currently consented (tier 3) UK offshore windfarm developments that could be piling at the same time as the proposed East Anglia THREE project, based on best available information on when the developments are likely to be piling. This indicative scenario is for illustrative purposes only and is likely to change but more accurately reflects the limitations and constraints to project delivery (see section 12.7 of Chapter 12).
- 8. European projects (*Table 12.5.2*) listed in tier 1-3 were considered for the CIA. However, the construction of all the European offshore wind farm tier 3 projects were screened out from the CIA as either there was no potential overlap with the construction of the East Anglia THREE project, based on the seven year window in which construction could occur (e.g. date of consent for tier 3 projects were in 2013 or earlier) or there was not sufficient information and certainty in project programmes to enable an adequate assessment.
- 9. The screening resulted in a list of 63 projects (39 UK and 24 European offshore wind farms) with the potential for construction, operation and decommissioning cumulative impacts on harbour porpoise. Of the 63 projects, 20 UK offshore wind farms have the potential for construction to overlap with the proposed construction of the East Anglia THREE project, all projects have the potential for operation and maintenance to overlap with the construction, operation and maintenance or





- decommissioning of the East Anglia THREE project, and all projects have the potential for decommissioning to overlap with the operation and maintenance or decommissioning of the East Anglia THREE project, and therefore have potential of cumulative impacts for harbour porpoise.
- 10. For grey seal 42 projects (34 in UK and 8 in Europe) have been screened in, with the potential of construction cumulative impacts for 16 UK projects; operation and maintenance cumulative impacts for all 42 projects; and decommissioning cumulative impacts for all 42 projects.
- 11. For harbour seal 27projects were screened in, 9 UK offshore wind farms with the potential of construction cumulative impacts; all27 with potential operations and maintenance cumulative impacts; and all 27with possible decommissioning cumulative impacts with the proposed East Anglia THREE project. The results of the screening are presented in *Tables 12.5.1 and 12.5.2*.

#### 12.5.3 Other renewables developments

- 12. Other renewable projects assessed in the CIA screening were tier 1-5 for UK based projects, and tier 1-3 for other European projects.
- 13. UK based projects listed in tiers 1-4 were screened in for potential construction, operation and maintenance and decommissioning cumulative impacts, if those phases could overlap with the proposed construction, operation and maintenance, and decommissioning of the East Anglia THREE project and sufficient information was available to determine this. No European projects have been screened in (tier 3 or above).
- 14. The results of the screening are in *Table 12.5.3*. A total of five projects were screened into the harbour porpoise CIA, two could have the potential for construction to overlap with the proposed construction of the East Anglia THREE project (however, piling is highly unlikely to be used during the installation), all five have the potential for operation and maintenance and / or decommissioning cumulative impacts with the East Anglia THREE project.
- 15. Only one project (PTEC) was screened in to the grey seal CIA for potential construction, operation and maintenance and / or decommissioning impacts. No projects were screened into the harbour seal CIA.

#### 12.5.4 Aggregate extraction and dredging (operational impacts only)

- 16. Aggregate extraction and dredging projects considered for the CIA screening were tier 1-3 for UK based projects (*Table 12.5.4*); no European projects were assessed in due to a lack of information.
- 17. No projects were identified in tier 2 or 3, and all of the tier 1 projects identified by screening were already active dredge zones, and although considered part of the baseline, these 54 projects were screened in for consideration during the CIA for marine mammals during the proposed construction, operation and maintenance and decommissioning of the proposed East Anglia THREE project.

#### 12.5.5 Oil and gas installations/activities

- 18. Oil and gas exploration and installations have the potential for cumulative impacts during construction, operation and maintenance, and decommissioning of the proposed East Anglia THREE project. Plans or projects considered during the CIA screening were tier 1-3 for UK based projects; no European projects are assessed in due to a lack of information.
- 19. All tier 1 projects considered in CIA screening were actively producing at the end of the baseline, and are therefore not considered for construction, operational and maintenance impacts. There is a large amount of uncertainty around decommissioning, and although there are a number of fields where production has ceased, no assumptions have been made about any decommissioning activities. Therefore this phase of oil and gas projects has been screened out of the CIA.
- 20. Oil and gas activities screened in to the CIA are tier 2 and 3 projects based on the 27th Round First Tranche of Offers, 27th Round Second Tranche of Offers and 28<sup>th</sup> Round First Tranche of Offers (see https://www.gov.uk/oil-and-gas-licensing-rounds#past-licensing-rounds for more detail). Confirming which of the License block or part blocks from these rounds are in which period of the Licence<sup>1</sup> or whether exploration or extraction may be occurring is outwith the scope of this CIA. It has been assumed that each of these plans or projects could be either in commissioning/exploration or operational phase during the lifespan of the proposed East Anglia THREE project.
- 21. *Table 12.5.5* lists the Licence blocks or part blocks (plans/projects) which have been screened in to the CIA. A total of 557 Licence blocks or part blocks have been screened in for harbour porpoise, 429 for grey seal and 135 for harbour seal.

22. A number of Licence blocks west of Shetland were also identified during screening, some of these block are on the boundary of the harbour porpoise North Sea Management Unit they have been screened out of the assessment due to the large spatial separation between the East Anglia THREE site and the location of these blocks.

#### 12.5.6 Navigation and shipping (operational impacts only)

- 23. Navigational and shipping projects considered in the CIA screening were tier 1-3 for UK based projects. All European projects were screened out. Projects were considered for potential operational impacts if the plan or project had not started by the end of the East Anglia THREE baseline.
- 24. No projects were identified in tier 2 or 3, and all of the tier 1 projects identified by screening were already active, and are therefore considered part of the baseline.
- 25. Therefore all navigation and shipping operations have been screened out of the CIA.

#### 12.5.7 Subsea cables and pipelines (commissioning/construction impacts only)

- 26. Subsea cables and pipelines only have the potential for cumulative impacts with the proposed East Anglia THREE project during their construction. Plans or projects assessed for the CIA screening were tier 1-3 for UK based projects; no European projects were assessed due to a lack of information.
- 27. No projects were identified in tier 2 or 3, and all of the tier 1 projects identified during screening were already installed, and are therefore considered part of the baseline.
- 28. Several major HVDC projects are in planning, including the Eastern Link HVDC cable, between Peterhead and Redcar, which is still in the planning stage and no detailed information is currently available. The NorthConnect Interconnector has been onhold, initially the expected delivery date was 2020 but there have been two years of delays and construction period is currently unknown.
- 29. Therefore all subsea cable and pipelines have been screened out of the CIA.

#### 12.5.8 Licenced disposal sites (operational impacts only)

- 30. Licenced disposal sites considered in the CIA screening were tier 1-3 for UK based projects; no European projects were assessed in due to a lack of information. Projects were screened in for potential operational impacts (construction and decommissioning impacts are not considered).
- 31. No projects were identified in tier 2 or 3, and all of the tier 1 projects identified by screening (*Table 12.5.6*) were already active sites, and are therefore considered part of the baseline, however, all 40 sites were considered in the CIA.
