Key views from the sheep ree are probably along the former road that passed in close proximity to the sheep ree but is now hidden by forestry activity.</p> <p>Current views in all directions are dominated by commercial forestry plantation. The infrastructure of the Proposed Development would be visible from the sheep ree but intervening localised vegetation would significantly reduce this visibility.</p> <p>The magnitude of impact has been assessed as Minor Adverse on an asset of Low value, with slight changes to setting with the introduction of infrastructure in immediate views west through to south east. Intervening and localised vegetation would likely impact on some of these views. These changes would not impact on the ability to understand and appreciate the sheep ree and its current setting. It is dominated by the commercial forestry on all sides and key views are probably along the path where there is visibility, and views towards any Post-Medieval agricultural structures in proximity to it.</p> <p>Current views in all directions are curtailed by the commercial forestry plantation. The infrastructure of the Proposed Development would be visible from the path in various locations but intervening localised vegetation would significantly reduce this visibility.</p> <p>The magnitude of impact has been assessed as Minor Adverse on an asset of Low value, with slight changes to setting with the introduction of infrastructure in close proximity to some areas of the path. Intervening and localised vegetation would impact on some of these views. These changes would not impact on the ability to understand and appreciate the path and its current setting.
