However, as agreed with Historic Environment Scotland (HES) in their consultation response to Craiginmoddie Windfarm application, this impact would not create a significance of effect that would be significant in EIA terms. Therefore, when considering the differences in methodology and bringing the Craiginmoddie Windfarm impact in line with the methodology set out above, the magnitude of impact should be stated as Minor Adverse due to the impact on a single key view from the castle, resulting in a significance of effect of Slight Adverse rather than Moderate Adverse, and therefore not significant in EIA terms. Consequently, the cumulative impact of the addition of the Proposed Development to a baseline along with consented and application developments would result in slight changes to the setting of the castle due to the impact from Craiginmoddie Windfarm, therefore the cumulative significance of effect would be Slight Adverse.
