1. MARINE ACTIVITIES

1.1. Summary:

Please be advised that circa the **01/04/2025**, Hughes Subsea Services intend to commence UXO Clearance works within the East Anglia THREE CDM zone along the Export Cable Route near Bawdsey. Locations for UXO clearance works are identified in section [2.1](#) of this document, diving operations will be carried out onboard the vessel **“DSV Curtis Marshall”**.

All vessels are required to maintain a minimum of 500 metres safety distance from “DSV Curtis Marshall” making minimal wash and navigating with caution.

1.2. Activity Description:

The scope of work for the “DSV Curtis Marshall” comprises of surface fed diving to conduct disposal of two confirmed unexploded ordnance. Whilst diving operations are underway, the vessel will display an alpha flag and make appropriate VHF announcements prior to commencing operations.

The **“DSV Curtis Marshall”** will be assisted by the **“GPS Battler”** workboat during mooring operations, with the **“Hughes Hunter”** Providing support during clearance operations.

The “DSV Curtis Marshall” will be working in 4-point mooring mode.

The Scope of work for the “GPS Battler” is to assist the “DSV Curtis Marshall” by deploying two anchors and Mooring cans to be used as part of the “DSV Curtis Marshall’s” 4-point mooring arrangement.


Whilst diving operations are underway, ‘DSV Curtis Marshall’ will display an alpha flag, broadcast relevant sécurité messages and will transmit an Automatic Identification System (AIS) message. All three Vessels will maintain a listening watch on VHF Channel 16 and VHF DSC Channel 70 continuously throughout operations.


1.3. Program Schedule:


The vessels are expected to mobilise in the port of Harwich and commence operations within the East Anglia Three Export Corridor Circa the 01/04/2025.

Diving Operations will be conducted during daylight hours and are dependent on tides. The scope completion will be notified by closure of this Notice to Mariners.

Figure 1 Showing Map of the CDM Zone:





Figure 2 Showing Map of the area:
