1. MARINE ACTIVITIES

1.1. Summary:

Mariners are advised that the vessel '**Seaspan Situla**' has redeployed **thirteen** autonomous recording units and **one** wave rider buoy within the East Anglia THREE Offshore Windfarm Area as per section [2.1](#) and [2.2](#). '**Norside Supporter**' will take over the noise monitoring activities and an updated notice to mariners will be distributed to advise of the vessel collecting the ARU's at a later date.

During the monopile installation noise monitoring campaign, all vessels are requested to keep a 500m safety distance from the Norside supporter.

1.2. Activity Description:

Seaspan Situla have redeployed **thirteen** moored stations on the seabed at distances of 500-750 metres, 1.5km, 3-6km and 8-15km. Each station will have a mounted hydrophone which will sit approximately **2.5 metres above the seabed**. The vessel-based deployed hydrophone is positioned in the middle of the water column.

Seaspan Situla have deployed a **wave rider buoy** to monitor conditions withing the East Anglia THREE offshore Windfarm Area as detailed in section [2.2](#) The Wave rider buoy is equipped with a **flashing yellow light**.


Light Range – 4 nm


All vessels are required to maintain a **500m safety distance** from this position.

- Collection of the Autonomous Recording Units (**ARU**) and wave rider buoy will be notified by future Notice to mariners.

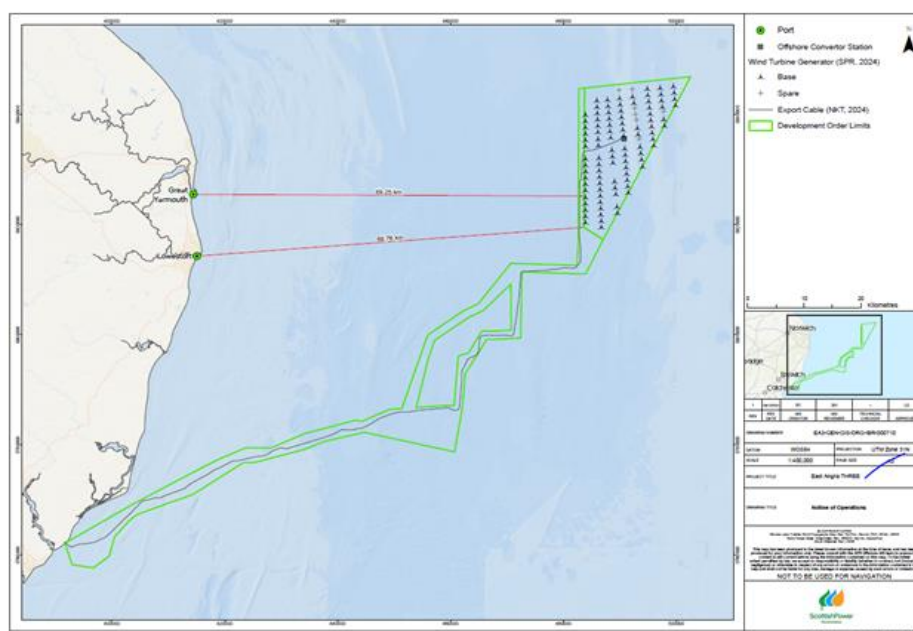

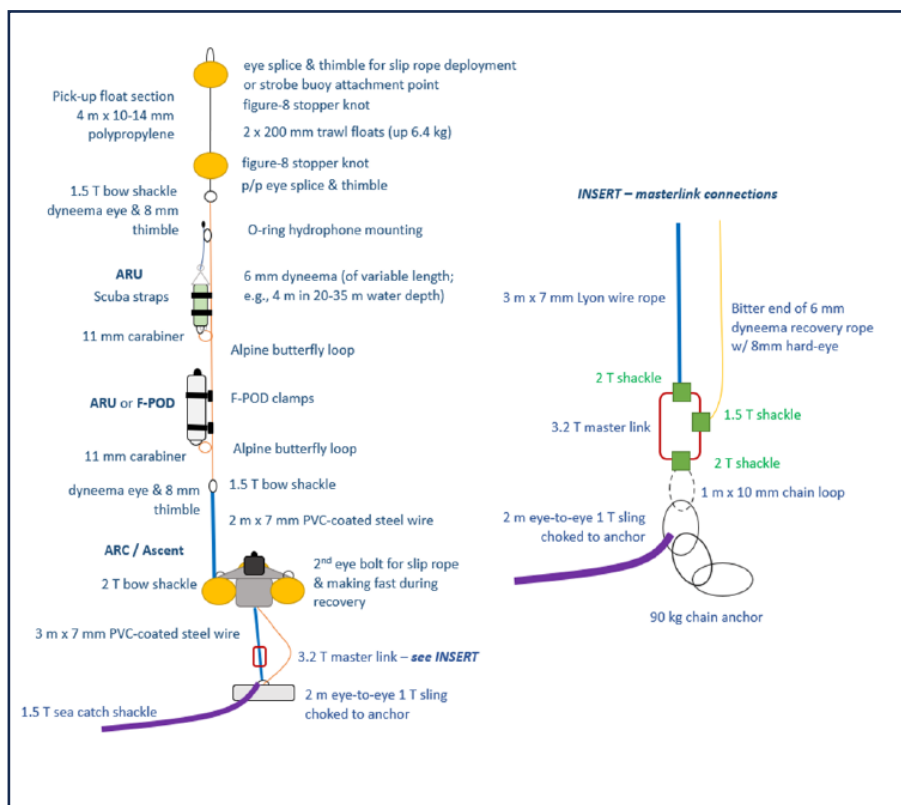
